**Minutes** The minutes of the April 6, 2021 meeting were approved as printed and distributed.

Treasurer's Report (Cathy Curtis) The following report was presented and will be filed for financial review: Checking Account Balance April 26, 2021 \$348.02; Income \$268.00 (\$268.00 Dues); Disbursements \$42.33 (\$25.00 Coordinating Council Dues, \$17.33 April *Nu's No*tes-Dorothy Dean); Checking Account Balance May 5, 2021 \$348.02; CEFCU Savings Account Balance \$29.66; CEFCU Money Market account \$7,447.51; Total Balance May 5, 2021 \$7,825.19.

She will send May birthday greetings to Karen Ball, Dorothy Dean, Karin Johnson and Sandy White. *Nu's Notes* deadline is May 15 for the May edition distributed in June. Mary Jane Sterling will continue to post ISLO Zoom links on Nu's website as requested. Women's Civic Federation dues for 2020-21 were paid April 30, 2020. Civic Federation did not meet in

2020-21 due to Covid and has not scheduled programs/location for 2021-2022. Nu Chapter will not pay dues for 2021-2022 at this time. Yearbook updates will appear in *Nu's Notes*.

Finance (Mary Jane Sterling) Mary Jane Sterling reviewed a summary of the projected receipts and disbursements for 2021-2022 and moved to adopt the proposed 2021-2022 Nu Chapter budget; motion passed.
