Peoria Women's Civic Federation Meetings

November 20, 2019

Beth Crider spoke to Peoria Women's Civic Federation at St. Paul's Lutheran Church. She joined the staff of the Regional Superintendent in 2011 when Dr. Gerald Brookhart appointed her his assistant. Upon his retirement in 2013 she was appointed Regional Superintendent by the Peoria County Board.

She spoke passionately on two issues. She focused on trauma of children and how that impacts teaching. The trauma comes in the forms of hunger, divorce, abuse, incarceration, drug and alcohol abuse, homelessness, witnessing trauma as part of everyday life, etc. Her second issue was that of teacher shortages and what solutions may be found.

Scheduled meetings of Peoria Women's Civic Federation are on the 3rd Wednesday of each month. Meetings are held at St. Paul's Lutheran Church on West Lake Street at 9:30 a.m. Meetings are open to members of Nu Chapter.

December 18, 2019

Peoria Women's Civic Federation held its December meeting at St. Paul's Lutheran Church on Lake Street at 9:30 a.m. After a brief business meeting Cindy Swanson introduced the speakers. Mary Anne Crenshaw and Becky Runyon shared aspects of the Baha'i Faith which includes the belief in being citizens of the world and encompasses all religions as part of a whole. It is their belief that Moses, Mohammad, and Jesus were each messengers of God and they use teachings from each of the major religions for their faith base.

In this faith there are no clergy, so the ladies presented their understanding of the teachings and shared hopefulness. There are people of the Baha'i faith in 240 countries and it began in the mid-1800s in Persia which is now Iran. It is central to the Baha'i faith that the purpose "of religion is to establish unity amongst the peoples of the world."

February 26, 2020

Peoria Area Women's Civic Federation met Wednesday, February 26, 2020 at St. Paul's Lutheran Church in Peoria. The speaker was Mark Willis, the Chief Financial Officer for Peoria Public Schools. He spoke to the financial overview of Peoria Public Schools, which is significantly better than five years ago when the State of Illinois was withholding funding. He also talked about the 5 Year Plan to improve the buildings owned by the school district and that in year 4 of this plan 99 of the 135 projects are completed.

The federation will meet again on March 25, 2020 at 9:30 a.m. at St. Paul's Lutheran Church. The topic for that meeting will be announced in the Peoria Journal Star.

May 6, 2020 Meeting

Everyone's favorite meeting is Wednesday, May 6! It's our annual book discussion of this year's Peoria Reads book, *The Hate U Give*. Roberta

NU Chapter (#13) General Membership Meeting, December 7, 2019

Business Meeting President Connie Voss called the meeting, at Notre Dame High School, to order at 10:45 a.m. followed by the recitation of *A Collect for Teachers*. Twelve members attended; a quorum was present.

Minutes The minutes of the November 4, 2019 General Membership meeting were approved as printed.

Treasurer's Report (Cathy Curtis) The following report was presented and will be filed for financial review: Checking Account Balance November 4, 2019 \$140.01; Income \$200.00 (\$200.00 transfer from Money Market Account); Disbursements \$200.00 (\$200.00 Emily Hrdlicka, Lincoln School recipient of Nu Chapter Grant); Checking Account Balance December 7, 2019 \$140.01; CEFCU Savings \$6.59; CEFCU Money Market account \$7,423.36; Total Balance December 7, 2019 \$7,569.96.

Communications and Marketing Nu's Notes deadline is February 20, 2020. Yearbook updates appear in December Nu's Notes. Camille Ratcliff reported that the Peoria Civic Federation meeting featured Peoria Regional Superintendent Beth Crider who spoke about teacher shortage, its effects, and what is being done locally to educate children exposed to trauma.

Educational Excellence The February 5, 2020 meeting at Peoria Public Library North Branch will feature "Day Trippin' with members sharing favorite one-day trips in Illinois (or near). Brochures featuring Illinois sites were distributed.

Professional Advancement and Outreach

The Nu Chapter Grant of \$200 awarded Emily Hrdlicka, a 7th grade teacher at Lincoln School, was used to take 75 students to see *Harriet*, a biography of Harriet Tubman. Shirley Dresden shared that Nu has \$153.62 toward the purchase of a \$450 Malawi well and encouraged members to donate "Change for Change." Shirley reported as of May 4, 2019, members had read a total of 6,333,770 minutes and requested members record minutes read since that time.

Coordinating Council The joint meeting of the Peoria Area Coordinating Council will be March 28, 2020 at Pekin Country Club. It was suggested Beth Crider be a speaker for a future meeting.

New Business Common Place will be merging with Neighborhood House effective January 1, 2020.

At the May meeting, amendments to the Chapter Rules will be presented. Among those being considered are:

Professional Advancement and Outreach Committee

IV 2 h)

Strike (5) confer with the chapter's representative on the Common Place Board (if there is currently such a representative) and

facilitate member participation in Common Place activities.

Rationale: With the recent merger of Common Place and Neighborhood House, Nu Chapter will no longer have a representative on the Common Place Board.

Strike (15) seek/select applications for the Florence A. Cook Recruitment Grant and submit one application annually per Illinois State Organization guidelines.

Rationale: This state grant is slated to be discontinued at the end of this fiscal year.

Something to consider:

Per Roberts Rules of Order, the name of the maker of the motion is to be included in the minutes. Organizations have the option of not including the name of the maker of the motion in the minutes if it is specified in their rules. If the chapter chooses not to include the name, the chapter rules must state that.

Nu Chapter Rules do not state otherwise so the name of the maker of the motion is included in the minutes.

Some organizations choose not to include the name to protect the identity of the maker.

Others choose to include the name so that if in the future, if one wished to obtain information regarding the rationale or thinking behind a motion passed or defeated, one would know whom to contact.
